# U.S. Maritime Administration PIDP Grant Approval

Application for \$15.6 million, with an additional Port match of \$10.4 million

#### **Discussion**

The Oregon Legislature passed Senate Bill 1567 in 2022, authorizing the Oregon Department of Environmental Quality (DEQ) to develop a program to improve the seismic resiliency of large-capacity fuel storage and distribution facilities in the event of a Cascadia Subduction Zone Magnitude 9.0 earthquake. The Port's goal is to bring Beaver Dock into compliance with the law and to modernize the dock. Following modernization, Beaver Dock will be a seismically resilient marine terminal capable of bulk fuel distribution on the Columbia River, providing support to the state's response and recovery efforts after a Cascadia event.

To fund the first phase of the Dock modernization, the Port applied for and received a \$2.7 million Connect Oregon Grant.

The U.S. Department of Transportation (DOT) Maritime Administration's PIDP Grant is currently open with applications due on September 10, 2025. The PIDP program provides funds for projects that improve the safety, efficiency, or reliability of goods through ports and intermodal connections to ports.

For this first phase, the Port will apply for funds to:

- Plan/Design/Permit improvements to Berth 1, Berth 2, Upstream Approach, replacement of the Downstream approach, and related seismic groundwork.
- Extend the pipe bridge through the lagoon to Berth 1.
- Realign pipelines and related infrastructure from the dock onto the pipe bridge.
- Demolish the remaining downstream approach or rail trestle.

In addition to the Connect Oregon \$2.7 million grant, the Port has \$2.2 million set aside for dock improvements, as well as insurance proceeds and tenant financial commitments to draw upon to fund the match. There is no set match amount; however, a higher match increases the chance of success.

#### Recommendation

Adopt **Resolution No. 2025-25**, authorizing Port staff to apply for the PIDP Grant Program for \$15.6 million, with an additional Port match of \$10.4 million.

## **RESOLUTION NO. 2025-25**

# A RESOLUTION AUTHORIZING A USDOT MARITIME ADMINISTRATION GRANT APPLICATION FOR BEAVER DOCK

**WHEREAS**, the Port is the owner of Beaver Dock at Port Westward, which is one of only five deep-water ports in Oregon; and

**WHEREAS**, in 2024, the Oregon State legislature passed Senate Bill 1567 requiring seismic resiliency improvements of large capacity fuel storage and distribution facilities such as Beaver Dock, to survive a design level earthquake (defined as a Cascadia Subduction Zone Magnitude 9.0 event); and

**WHEREAS,** the Port conducted technical structural assessments of the Beaver Dock facility and has developed a multi-phase plan for the modernization of Beaver Dock to meet the new State seismic resiliency requirements and ensure continuity of operations; and

**WHEREAS**, the first phase of the multi-phase modernization plan includes relocation of the pipelines serving Berth 1 and is estimated to cost \$26 million; and

**WHEREAS**, the U.S. Maritime Administration FY 2025 Port Infrastructure Development Program (PIDP) Notice of Funding Opportunity is currently open; and

**WHEREAS,** the Port received a Connect Oregon grant award of \$2.7 million for the Beaver Dock Modernization Project, which can be leveraged as matching funds; has \$2.2 million set aside in the Beaver Dock Maintenance Fund; and tenants Columbia Pacific Bio-Refinery and NXT Renewable Fuels have both signed commitment letters pledging matching funds, if the grant is awarded; Now, therefore

**BE IT RESOLVED** that the Port Commission authorizes an application to the U.S. Maritime Administration PIDP Grant Program for an estimated \$15.6 million grant to fund the Port Westward Energy Security, Seismic Resilience, and Modernization – Phase 1 and set aside up to \$10.4 million in Port funds, including funds received from Connect Oregon and Port tenants, toward grant matching requirements.

# U.S. Dept of Transportation RTA Grant Approval

Application for up to \$2.5 million

#### **Discussion**

The Oregon Legislature passed Senate Bill 1567 in 2022, authorizing the Oregon Department of Environmental Quality (DEQ) to develop a program to improve the seismic resiliency of large-capacity fuel storage and distribution facilities in the event of a Cascadia Subduction Zone Magnitude 9.0 earthquake. The Port's goal is to bring Beaver Dock into compliance with the law and to modernize the dock. Following modernization, Beaver Dock will be a seismically resilient marine terminal capable of bulk fuel distribution on the Columbia River, providing support to the state's response and recovery efforts after a Cascadia event.

The Port is in the process of applying for a \$15.6 million grant under the U.S. Department of Transportation (DOT) Maritime Administration's Port Infrastructure Development Program (PIDP) to fund the first phase of Port Westward Modernization and Seismic Stability Project.

The DOT is also accepting applications for its Rural and Tribal Assistance (RTA) Pilot Program. This program provides funding for planning and design phase activities for rural and tribal infrastructure projects. Grants under this program may be used for staffing and hiring third-party firms to provide financial, technical, and legal assistance with project planning and design. RTA grants are awarded on a first-come, first-served basis to eligible applicants and projects.

RTA grants do not require a match and, therefore, fits well with the Port Westward Energy Security, Seismic Resilience, and Modernization - Phase 1 efforts as it would provide an additional source of funds for that project.

#### Recommendation

Adopt Resolution No. 2025-26, authorizing Port staff to apply for an RTA Grant of up to \$2.5 million.

**BE IT RESOLVED** that the Port Commission authorizes an application to the U.S. Maritime Administration RTA Grant Program for up to \$2.5 million to partially fund planning, permitting, and preliminary engineering of the Port Westward Energy Security, Seismic Resilience, and Modernization – Phase 1.
