### NEXT RENEWABLE FUELS LEAPS FORWARD IN 2023

Following a series of major updates in early 2023, NEXT Renewable Fuels (NEXT) is accelerating its pursuit as a leader in the renewable diesel and sustainable aviation fuel industry, with its clean fuels facility at Port Westward as just the starting point.

NEXT has received its key local and state permits to develop its facility at Port Westward and is advancing through the federal permitting process. The company also signed a business combination agreement with Industrial Tech Acquisitions II, Inc. (Nasdaq: ITAQ) to become the first public, large-scale clean fuels and feedstock aggregator.

Adding to this momentum, United Airlines Ventures is investing up to \$37.5M in NEXT as part of its \$100M sustainable aviation fund. This investment has helped NEXT gain recognition as one of the 50 Hottest Companies in the Bioeconomy in 2023. Chris Efird, CEO of NEXT, spoke at the annual Advanced Biofuels Leadership Conference in Washington, D.C., underscoring the company's leadership role in the industry.

Further strengthening its corporate foundation, NEXT recently welcomed Lisa A. Holmes, MSHR, and Stephen Trauber, former Citibank Vice President, to its Board of Directors. Their expertise will guide NEXT's growth, workforce expansion, and capabilities in the energy transition sector.

The team at NEXT is beyond grateful to receive ongoing and extensive local support, including from local leadership, union leaders, a recent endorsement by The Daily News Editorial Board, and a jointly signed letter by the Oregon Coastal Caucus, a group of seven Oregon Senate and House elected officials representing the Oregon coast.

## SECURITY AT TRESTLE BEACH THIS SUMMER

MetroWatch, a licensed security provider, will provide onsite security at Trestle Beach again this summer Memorial Day through Labor Day. Since beginning the security program in 2021, the Port has seen a significant decline in the number of safety incidents at the beach.

"We know Trestle Beach is one of the few places in St. Helens and Columbia County where citizens have beach access to the river," said Sean Clark, Port Executive Director. "The Port is willing to take on the extra expense to ensure it remains a safe place for the public to enjoy."

Trestle Beach is an industrial property that the Port has opened as a recreational river access point for the public to enjoy the beach. Summer hours at Trestle Beach are 8:00 am to 7:00 pm. Parking is available through the Columbia City Industrial Park access gate. The gate is locked at closing time. ### MAINTENANCE TEAM KEEPS PORT RUNNING SMOOTH

The Port is fortunate to have an extremely qualified maintenance team on staff that consistently goes above and beyond to keep the Port operational and up to code. Between them, they have inhouse expertise in plumbing, electrical, roofing, fire suppression systems, carpentry, welding, and metal work.

The Port has 42 commercial and industrial tenants, and over 100 individual tenants each at the Scappoose Airport and Scappoose Bay Marine Park. The maintenance team is quick to respond to tenants' needs and are available on call at all hours, including nights and weekends. For example, they are the first to respond when there is a snowstorm, shoveling snow off the docks and boat house rooftops to keep the marina from collapsing.

"Our maintenance team always puts the Port's best interest first in serving our tenants and recreational users," said Miriam House, Port Operations Manager. "They are a well-oiled machine, willing to do whatever it takes to get the job done."
