## Bayport RV Park and Campground Rules and Regulations

### GENERAL CAMPGROUND RULES

All park users should take precautions to safeguard their personal property. The Port will not be responsible for lost, stolen or damaged property, or for the personal safety of campers or other visitors.

Guests may check in after 2:00pm. Check-out is at 12:00pm on the day of departure.

Overnight camping is limited to fourteen (14) nights in any seventeen (17) day period and no more than 60 days in one calendar year, unless prior permission is given by the Port.

Reservations can be made online at [www.portofcolumbiacounty.org](http://www.portofcolumbiacounty.org), or by calling the Port at 503-397-2888.

Guests without a reservation must check-in with Port staff at the Marina/RV Park office or with the Scappoose Bay Paddle Center staff for an available site. Payments for your site can be made at the pay station located on the sidewalk near the Padding Center building.

Reservations are fully refundable, less a \$5 reservation fee, if cancelled within 48 hours' notice. Boat launch fee is included in your RV Park reservation.

At all hours, especially during quiet hours, 10:00pm to 8:00am, please respect the rights of others to peace and quiet.

Disorderly conduct is unacceptable and may result in a notice to vacate. No person shall endanger the health, safety or welfare of another person, nor harass or intimidate another person.

No person within a park area shall possess any loaded firearm or discharge any firearm, pellet gun, bow/arrow, slingshot or other weapon capable of injuring any person or wildlife.

Possession, or discharge of any firecrackers, explosives, rockets, fireworks or other substances which could be harmful to park, visitors, neighbors or resources is prohibited.

Damage, defacing or removal of any flora or fauna, animals, or park structures, including but not limited to buildings, signs, fences, tables, benches, fountains, etc.; is prohibited.

Bottles and cans are recyclable and have designated receptacles. Garbage cans are to be used by park visitors for kitchen type garbage generated at the park only. Dumping of electronics, appliances and other rubbish is prohibited.

Visitors and campers shall leave all park restrooms and grounds in a clean and tidy condition after use or a maintenance cleaning fee will be imposed.

Children the age of 12 and under are not permitted on the docks without a life preserver and must be accompanied by an adult. Loaner life jackets are available at the pay station.

### VEHICLES

All motor vehicles must be licensed and display current registration. No trailer is permitted on premises without a working tow vehicle.

Motor vehicles are not to exceed five (5) miles per hour in the park unless otherwise posted.

Vehicles may only be parked in authorized parking areas. Abandoned vehicles, or those inappropriately parked, may be towed at the owner's expense.

Onsite maintenance, repair and washing of vehicles is prohibited. Remodeling or construction to RV's, trailers and such is prohibited.

No all-terrain vehicles (ATV's), dirt bikes or other off-road vehicles may be operated in the park.

### PETS AND ANIMALS

All pets must be on a leash when on Port property. Do not tie pets to water or electrical hook-ups. Pets must not be left unattended. Unattended pets may result in intervention by animal control.

Pet owners shall immediately remove and dispose of their pet's waste on any and all premises of Port property. Failure to do so may result in a notice to vacate.

No animal shall be allowed to infringe upon another visitor. Infringement includes loud and/or repetitive noise being made by the animal, especially during the "quiet hours" of 10:00pm to 8:00 am.

### CAMPFIRES

Campfires are permitted in authorized fire rings only. It is not permitted to gather firewood from anywhere at the RV Park or Marine Park. Firewood is available for purchase at the Scappoose Bay Paddling Center.

At the discretion of the State Forestry Department or Columbia River Fire & Rescue, fires normally permitted in park areas may be restricted or prohibited due to high fire hazard conditions.

### BOATING

For your safety, there is NO fishing, swimming, or diving from Port docks, boat ramps, tie-ups, walkways or anywhere in the marina.



## Frequently Asked Questions

### Question 1: I don't have a reservation, how do I make one?

Reservations can be made online at [www.portofcolumbiacounty.org](http://www.portofcolumbiacounty.org), or by calling the Port office at 503-397-2888. You may also go to the Marina/RV Park office or see the Paddling Center staff for assistance. Please do not park in the campground until you have either made a reservation or confirmed with staff that the site number of your choice is available; it may be reserved.

### Question 2: Where can I pay for overnight stays without a reservation?

There is a pay station next to the Paddling Center building on the sidewalk that will process your payment. It accepts credit/debit cards or cash, but does not give any change. You will be given a receipt (sometimes it takes a bit to process before printing), please place your receipt in your RV window or dash so that it is visible at all times.

### Question 3: What are the check-in/check-out times and length of stay?

Check-in is 2pm; check-out is 12pm. The maximum length of stay is 14 nights.

### Question 4: Can I launch my boat and leave it on the dock?

Launch fees are included in your RV Park reservation. Overnight moorage is available for a fee if you choose to leave your boat at the marina. Your boat can be moored on Dock A, that's the first dock closest to the shore. Moorage fees can also be paid at the pay station.

### Question 5: Are there restrooms, showers and Wi-Fi?

There are restrooms in the building nearest the RV Park with coin operated showers. Your pay station receipt or on-line confirmation will show the Wi-Fi codes and security codes to the restrooms.

### Question 6: What about parking extra vehicles and boat trailers?

Our campsites are intentionally designed longer and wider than usual to accommodate an extra vehicle or truck and trailer. If you are having issues with parking in your campsite, arrangements may be made with Port staff to receive a parking pass enabling you to park in the vehicle/boat trailer parking lot at no charge. Please visit the Marina/RV Park office.

### Question 7: Where are the closest dump sites?

Bayport RV Park has an onsite automated RV dump station. Please note, the dump station only accepts credit cards.
